- Shotguns may not necessarily be used
- For WC, WCI and WCX Tests, handlers may not wear distinctively white or light clothing at any time, except for the blinds in WCX when a white handling jacket may be worn.

- Please check in with the Marshall upon arrival at your stake
- Refunds will be given for bitches in season only. A Veterinarian's Certificate must be submitted before the start of the test.

- Dogs are expected to run in numerical order at all stakes. If a conflict arises, it is the responsibility of the Handler to clarify the conflict with the Marshall at each stake.
- Handlers may be required to handle a gun during the WCX Test. Gun safety is considered as part of the test.
- It is the responsibility of the Entrant/Handler to be familiar with the CKC Rules and Regulations for Working Certificates.
- “It shall be the duty and obligation of the test giving club to see that a Judge, Club Official, Volunteer or any participant at a WC Test held under these rules, is not subject to indignities of any kind.”
- Running order will be determined by random draw at the home of the Test Secretary one hour after closing. A catalogue and running order list will be provided to entrants on the day of the test.
- Test Headquarters is at the N.E.T. Camping Resort, 2325 Regional Road 24, Vineland Station, Ontario, L0R 2C0.
- Please note that food will not be available in the camping resort

DIRECTIONS TO NET CAMPING RESORT

FROM TORONTO: Take the QEW to Niagara, Exit #57 (Victoria Ave) Vineland take the off ramp, to a stop sign. At the stop sign turn right. This takes you to a set of lights, turn left onto Victoria Ave (Regional Road #24). Follow Victoria Ave. 12km South and the resort will be on your left hand side.

FROM NIAGARA FALLS: Head West on Lundy's Lane (Hwy 20) for 20km then turn right onto Regional Road #24 (Victoria Ave.) travel 4km and the resort is on your right hand side.

Other Fees

- A Listing Fee of \$8.35 (including GST) must be submitted for any dog without an individual CKC registration number or ERN.
- There will be a \$25.00 charge for NSF cheques and notification to the CKC
- The above noted entry fees include admission to the test site.
- **An additional \$5.00 per person will be charged at the gate for persons other than the handler.**
